1. AFRCC Mission 14M0464A opened and closed on September 16, 2014 for an aircraft reported missing on a flight from San Jose (RHV) to Lone Pine, CA. CAP aircrews launched rapidly after alert, and performed high altitude night DF activity to determine the approximate location of the missing aircraft. Another CAP aircrew launched early the following morning and shortly located the downed aircraft and the pilot (who had survived the emergency landing) on a rocky plateau at almost 11,000 feet altitude. A helicopter from the National Park Service was called in and subsequently picked up the pilot and transported him to the hospital.


